IPAC for Clinical Office Practice – New PHO Resource

Public Health Ontario (PHO) has announced a new infection prevention and control (IPAC) resource, called [At a Glance: Infection Prevention and Control Organizational Risk Assessment for Clinical Office Practice](#). PHO describes this resource as providing a step-by-step approach for identifying and managing IPAC organizational risks in clinical office practices. Effective organizational risk assessments (ORA) can help improve safety for both patients and staff in clinical office practices. There is an [accompanying form](#) to perform an ORA.

Additionally, earlier this year, PHO released an updated [IPAC Checklist for Clinical Office Practice: Core Elements](#). This resource is designed to help clinical office practices examine, evaluate (e.g., through self-assessment), and benchmark their current IPAC practices against provincial recommendations. - **Pneumococcal 15-valent conjugate (Pneu-C-15) (Vaxneuvance)**
- **Pneumococcal 20-valent conjugate (Pneu-C-20) (Prevnar 20)**

Assessing Alcohol Risk in Light of Expanded Access in Ontario

By the end of October, alcohol will be more accessible in Ontario as all grocery, convenience, and big-box stores will be able to sell beer, cider, wine, and ready-to-drink alcoholic beverages.

Increased retail access to alcohol may result in increased consumption and health risks.

The Canadian Centre on Substance Use and Addiction has updated [Canada's Guidance on Alcohol and Health](#), which replaces the 2011 Low Risk Alcohol Drinking Guidelines. Health care providers can use this guidance to identify higher-risk alcohol use and to support patients in assessing their risk of harm from alcohol use.

In contrast to the previous version of the guidance, this iteration presents a continuum of risk rather than numerical limits for weekly and daily alcohol consumption. Health care providers can communicate to their patients that even low levels of alcohol consumption can have adverse health effects; less is better when it comes to alcohol use.
